In anticipation of WIA reauthorization and Fiscal Year 2011 funding proposals, some are asking if [Recovery Act](#) investments have expanded worker training or led to WIA reforms, like sector partnerships and career pathways, encouraged under USDOL guidance. Anticipating Priorities in State of the Union, Budget Address

It is likely that economic recovery and job creation will be among the key themes in President Obama's January 27 State of the Union address, where he is expected to [outline an agenda](#) to help middle class families by "creating good, sustainable jobs" as well as "reverse the overall erosion in middle class security" by promoting tax credits for child care, lower payments for student loans and automated IRA deposits. Job creation and job training have dominated [headlines](#) across that nation of late and were the subject of the President's [town-hall meeting](#) on January 22 at Lorain Community College in Ohio. The President's budget, to be released on February 1, is expected to reflect these priorities.

House Passes Jobs Bill, Senate to Take Action

The House passed the [Jobs for Main Street Act of 2010](#) on December 16. In addition to infrastructure investments and funding to prevent education and public safety layoffs, the bill included \$750 million in competitive grants for job training in high-growth and emerging fields, and \$500 million for summer youth employment programs. Though the Senate has not introduced its bill, the Appropriations Subcommittee on Labor, Health and Human Services, Education, and Related Agencies held a hearing on January 21. National Skills Coalition Leadership Council member Marlena Sessions, CEO for Workforce Development Council of Seattle-King County, [testified](#) before the Subcommittee.

Attended by over 50 employers and community organizations, Sen. Jack Reed (D-RI), and staff for Rep.
